ARTICLE IV MEMBERSHIP MEETINGS

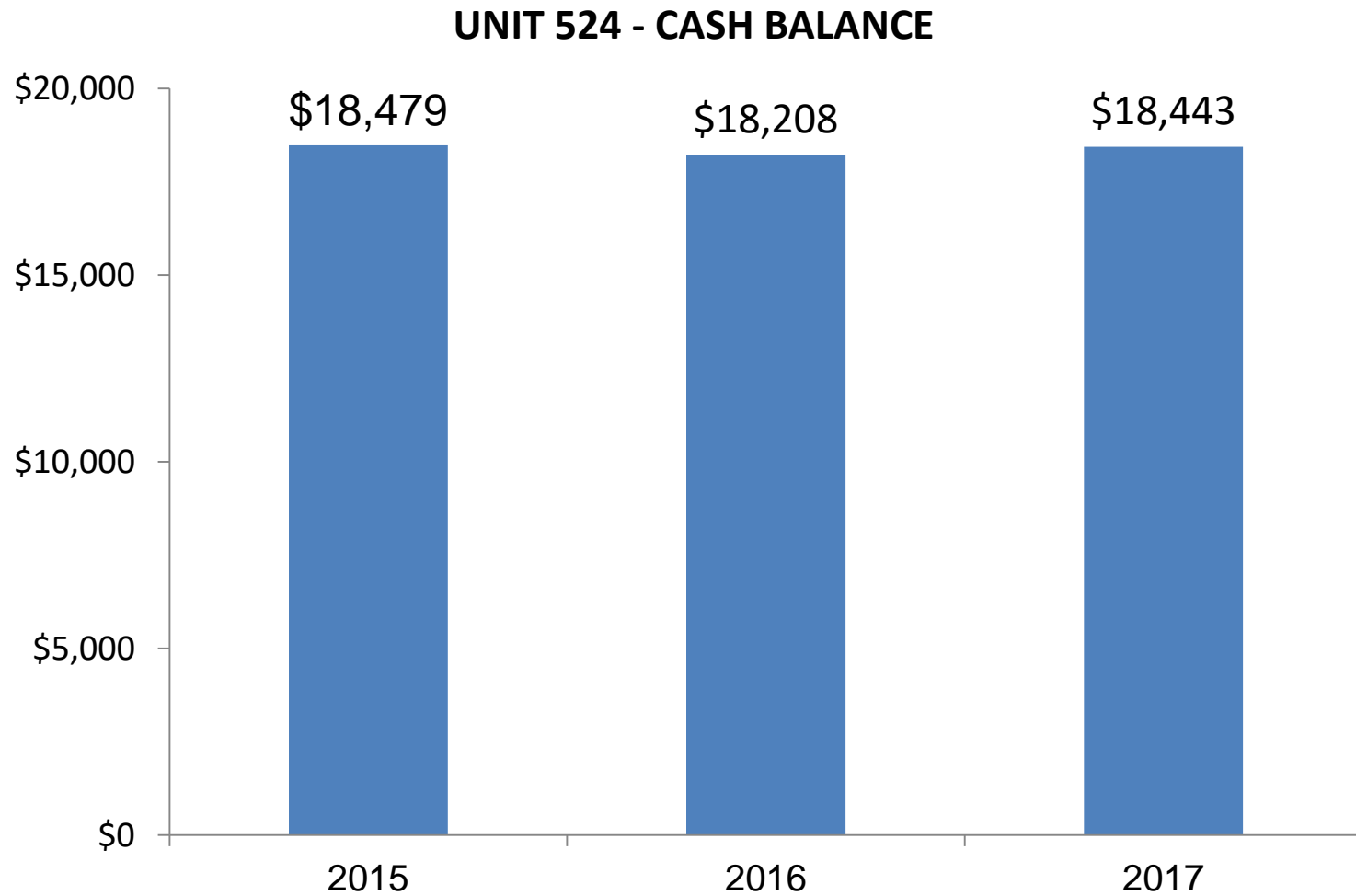
A - An annual meeting of the members shall be held on the day of the Unit's last playing event of the year.

ARTICLE V UNIT BOARD OF DIRECTORS
